According to the India State of Forest Report 2021, the forest cover is currently at 21.67% of the total geographical area. India formulated its first National Forest Policy in 1952, aiming to bring 33% of the land under forest cover to maintain ecological stability.

In 2001, the India State of Forest Report (ISFRs) made some big changes to the way they classified and counted pixels in a satellite image as forest. They began using finer-scaled satellite imagery and an entirely digital workflow to analyse them. In addition, the ISFRs also changed their definition of a forest. They now explicitly included any lands of at least one hectare area and with 10% or more tree cover, regardless of the tree species on the land, or the purpose for which it was grown, or its ownership, as forest. So, all of a sudden, tea estates, coconut plantations, mango orchards, homestead gardens of suburban housing developments, and even tree-lined avenues in densely built-up cities were being classified as 'forest'. In one stroke, just between the 1999 and the 2001, this redefinition helped raise India's forest cover by over 38,000 sq.km., the size of Kerala. So can a true environmentalist rely on this existing figures?

If you call yourself an environmentalist but do nothing to push for these necessary laws, then indirectly, you're contributing to the destruction of forests / environment / every sentient being. You're essentially wasting time, playing into the hands of elites who want us to engage in meaningless activities. we've witnessed numerous deforestation drives in ecologically sensitive and biodiversity-rich areas: the Aarey Forest in Mumbai (2019 & 2022), the Aravalis range from Rajasthan to Delhi, the Dantewada Forest in Chhattisgarh (2012-2022), Buxwaha in Madhya Pradesh (2021-2022), and unplanned commercial activities in eco-sensitive regions like Ladakh, Uttarakhand, Himachal Pradesh, and the Himalayan region. The ruling class and paid media occasionally offer token successes to make a hero out of someone, creating a fake opposition to pacify the movement. This tactic diverts attention from the core issue, leading activists away from genuine reform efforts. Rather than pursuing lasting legal changes, we get stuck in endless cycles of rallies and slogans—merely a distraction. Despite regular protests against deforestation and for environmental conservation, nothing changes. The government continues to exercise pure dictatorship, suppressing the voices of ordinary citizens, harassing true environmentalists, and filing fake cases against them. The result? Real activism for bringing citizenempowering laws that can achieve environmental conservation is sidelined, and the destruction continues.

After sending, a photo of this open order postcard can be uploaded to various social media groups and personal accounts to spread awareness and ensure that this solution-oriented, law-based

No one holds the authority to alter the proposed drafts, which are designed to solve systemic problems in society. - Moreover, the time, date, and place are fixed: for example, the 5th of every month at 5 p.m. at your local main post office. Informed citizens and activists gather there regularly to send these written demands in the form of proposed laws. As the

number of participants increases, pressure mounts on the ruling class (esp.Chief Minister and Prime Minister) to implement these citizenempowering laws. With more citizens sending open demands for these laws, it becomes evident that public common knowledge of these solution-oriented laws is growing. The ruling class then realizes that failing to implement these laws could damage their public image and potentially cost them the next election.

- Any conventional movement, protest, or demonstration relies

heavily on paid media (acting as a middle men - such as media outlets, YouTubers, print media like newspapers, radio, etc., which are now owned by foreign entities) to spread its message to the masses and, ultimately, to the apex authorities. This reliance on paid media gives them the power to selectively present or twist the demands in ways that align with the interests of their masters i.e. foreign powers. As a result, the movement becomes weakened, as the public information, discouraging widespread support.

- A more effective approach to breaking this dependency is this decentralized Draft Lead mass movement that <u>directly reaches</u> the apex authorities (i.e., the Prime

Since a postcard is an open letter format —meaning all postal staff from the sender's location to the destination can read its contents—the sender's demands, written boldly (such as say "Jury Court" - name of a citizen-empowering law), become visible to many. When the same word or demand appears every month, from multiple citizens across different

post offices across the country, it naturally piques curiosity. This repetition further helps create common knowledge about these proposed citizen-empowering laws. In turn, further breaking through the narrative controlled by paid media, which often aims to keep the public unaware of real solutions and the empowerment of the masses.

However, as soon as the 2022 Vidhan Sabha elections were announced, Gurnam Singh Charuni, a prominent farmer leader, declared his intention to form a political party solely focused on farmers' issues and to contest elections centered around these farm laws.

In response, Prime Minister Narendra Modi revoked all three farm laws, likely spurred by the fear that a genuine political opposition might arise, especially with elections on the horizon.


